The village board approved the hookups if the Town of Croghan was asked to form a water district. Mr. Marcus Hills, Mr. Mark Hills and Mr. Ryan Everson left the meeting.

Mr. Robinson also reported the lift station at Red Rooster will be installed the first week of June.

Mr. Robinson acquired two quotes for trench boxes from Blue Book.

Mr. Kalamas has no new updates about National Grid Transmission Lines.

The board discussed possible solutions to the Bank Street puddle issue.
